

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY
RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus that causes COVID-19 has been declared a worldwide pandemic by the World Health Organization. **The virus is contagious** and is believed to spread mainly from person-to-person via respiratory droplets through close interactions. As a result, federal, state, and local governments and federal, state, and local health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

HOMENETMEN (ARMENIAN GENERAL ATHLETIC UNION), a California 501(c)(3) nonprofit corporation, (“the Organization”) has put in place preventative measures to reduce the spread of COVID-19; however, the Organization **cannot guarantee** that you or your child(ren) will not become infected with the coronavirus. Further, **attending and/or participating in the Organization’s activities and/or events could increase** your risk and your child(ren)’s risk of contracting COVID-19 and possibly exposing others you interact with.

By signing this agreement, I acknowledge the contagious nature of communicable diseases, including but not limited to COVID-19, and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by the coronavirus, and possibly pass it on to others whom I or we interact with, by attending and/or participating in the Organization’s activities and/or events now or in the future and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by the coronavirus by attending and/or participating in the Organization’s activities and/or events now or in the future may result from the actions, omissions, or negligence of myself and others whether now or in the future, including, but not limited to, the Organization, and the Organization’s officers, directors, board members, members, employees, representatives, volunteers, agents, program participants, and the families of the Organization’s officers, directors, board members, members, employees, representatives, volunteers, agents, program participants.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself, including, but not limited to, personal injury, illness, permanent disability, death, damage, loss (including consequential loss), claim, liability, or expense of any kind, that I or my child(ren) may experience or incur in connection with my or my child(ren)’s attendance at or participation in the Organization’s activities and/or events whether now or in the future (“Claims”). I also understand that my child(ren) and/or I may expose and infect others through direct interaction with others. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Organization, its officers, directors, board members, members, employees, representatives, volunteers, agents, contractors, and program participants, and the families of the Organization’s officers, directors, board members, members, employees, representatives, volunteers, agents, program participants, of and from and against the Claims, including any and all liabilities, claims, actions, judgments, damages, penalties, fines, costs, losses (including without limitation, sums paid in settlement of claims, attorney fees, consultant fees, expert fees, and litigation costs), or expenses of any kind arising out of or relating thereto whether now or in the future. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Organization, its officers, directors, board members, members, employees, representatives, volunteers, agents, and program participants, and the families of the Organization’s officers, directors, board members, members, employees, representatives, volunteers, agents, program participants, whether a COVID-19 infection occurs before, during, or after attendance at or participation in any of the Organization’s activities and/or events now or in the future.

I acknowledge, affirm, and represent that I have carefully read this entire Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 completely and carefully, fully understand its contents, terms, and meaning, and have had an opportunity to have any questions answered to my

satisfaction. I understand that I am giving up substantial legal rights and remedies by signing this agreement. I hereby sign this agreement of my own free will and knowingly, freely, voluntarily, and expressly agree to be bound by all of its terms and conditions for today and all future attendance at or participation in any of the Organization's activities and/or events.
